Small claims processes in B.C. have changed. As of June 1, 2017, the Civil Resolution Tribunal began resolving most small claims up to \$5,000. The monetary jurisdiction for small claims cases in Provincial Court has been increased to \$35,000 and simplified trials at Richmond and Robson Square now include cases up to \$10,000.
